INTRODUCTION TO THIS YEAR'S TOPIC

Europe is slowly emerging from Covid-19. It has been a major health crisis and a magnifier of multiple challenges that have been left without a solution for far too long. So, while every vaccination increases the hope that life can slowly return to 'normal', there is at the same time a legitimate question about what the new normal will be. The European progressives, who have just been in the driving seat of the Social Summit in Porto, are very clear that the path forward must involve a fight – a fight against inequalities and for strong welfare states; against injustice and for a sustainable economy; against abuse and for resilient democracy in Europe and across the globe. How to make this happen, how to close the social gaps and how to act upon our solidarity are the questions at the core of the conversation that we as FEPS will hold at Call to Europe

10. Be part of it and you will contribute to shaping the policy proposals that will be discussed and the way to making them reality. This opportunity is just a click away!

MIND THE SOCIAL GAPS...

The aftermath of the Covid-19 pandemic is tragic. It is leaving Europe like a battlefield covered with landmines, each of which represents a social gap and each of which can cause another explosion. It will take much leadership, perseverance and boldness to navigate this minefield and to build a bridge to move beyond. Some of the particularly large gaps to be bridged are the:

- **Gender gap.** Since the pandemic has been an asymmetric shock, it has seen many women struggle to carry on with their professional lives and combine these responsibilities with the increased demands to provide care for their loved ones. The number of challenges in the fight for gender equality have risen and they can only all be tackled if Europe manages to build caring economies and caring democracies.
- **Income gap.** During lockdowns, low-income people have had fewer opportunities to continue employment and have been the first to feel the painful consequences of precarious contracts and hazardous working conditions. Now is the time for Europe to focus on delivering on its promise of more and better jobs, with more lifelong learning opportunities and adequate social protection.
- **Territorial gap.** Covid-19 has attacked disadvantaged regions the hardest. More people have died in these regions because of a lack of adequate health infrastructure and a lack of means to protect themselves against exposure. This is the toll of the neoliberal decades and austerity, and Europe needs to recover from it by investing and by improving the quality of public services for everyone across the European Union.
- **Intergenerational gap.** 2020 made Millennials and Generation Z fall behind in terms of living and working conditions. The opportunities they hoped to grasp have become out of reach and the dreams they hoped to achieve by conquering the world to improve it seem to have blurred behind an unreachable horizon. The time is now for Europe to act and to put in place a new social contract that embodies intergenerational solidarity.

The European Union must become the driver of progressive transformation – and that is the Call that FEPS, together with its members, partners and community of speakers, is making this year.

There may be no other chance like the present to ensure a systemic shift in our commitments towards carbon neutrality. This Call to Europe 10th anniversary edition marks the start of what scientists consider to be the most defining ten years in the future of our planet. The EU Green deal, and implementation of EU and national climate laws, offer very positive developments, yet there is still a huge gap in what needs to be done.
